But in 1881 seventeen college women in the Boston area (several different colleges) shared the belief that women could learn and accomplish whatever they had the intellect and energy to They had done it and they accomplish. knew other women could too! They founded the American Association of University Women, AAUW. For 137 years AAUW has worked for our rights to vote, to work, to go to school. AAUW members have marched, demonstrated. researched and taken

positions on the issues affecting women—educational, social, economic and political. AAUW has awarded more moneys for women's scholarships and research than any other organization in the world!"


were awarded to three young ladies who had their project boards on display.

## **New STEM FUND**

Ron Glasgow has established the Marie Glasgow and AAUW Friends STEM for Girls Scholarship Fund to be managed by the Lee County Schools Foundation. Ron introduced the Fund at the luncheon meeting by first speaking about Marie.

Marie was a member of an immigrant family that fled the Ukraine in fear of persecution for their religion and their educational stature. She arrived in the U.S. at the age of five and learned to speak English by attending her grammar school classes. She was passionate about the value of education and the opportunities that education provided to an individual and earned two Masters and a Doctorate degrees while raising a family and working most of the time.

Marie felt strongly about the Mission of AAUW Fort Myers. While our president she was very involved in funding our AAUW scholarships. Ron has established a FUND in her memory to benefit the Thomas Edison – Kiwanis Regional Science Fair in the Junior division and the Inventor's Fair. Ron distributed a lovely brochure detailing the Fund to all present. AAUW is honored to add this Scholarship to our Branch and we look forward to supporting the Fund's

growth and purpose to encourage young middle school girl's interest in STEM.

## AAUW, Florida Legislature

## **AAUW Bills of Interest--Florida 2019 Legislative Session**

Draft 1/31/19: please note legislative plans still under construction. Also please note that these bills have not been vetted by National AAUW; however, several were filed last year and vetted then. New bills are so marked.

D = Democrat, R = Republican, H = House, S = Senate

#### **Priority A**

**SUPPORT** H 419, S 474, Discrimination in Labor and Employment (the Helen Gordon Davis Fair Pay Protection Act)

House: Dotie Joseph D-108 (North Miami)

Senate: Linda Stewart D-13 (Orlando area), Lori Berman D-31 (Palm Beach area)

Prohibits an employer from providing less favorable employment opportunities to employees based on their sex; provides exceptions; provides an affirmative defense; provides civil penalties. This bill includes prohibitions against employer retaliation against employees who discuss salary and against requiring salary history in the hiring process.

**SUPPORT** The Equal Rights Amendment

HCR 209 Dotie Joseph D-108, SCR 266 by Audrey Gibson D-6 (Duval County), HCR 255 by Patricia Williams D-92

## **Priority B**

**SUPPORT** HB 49, SB 332, Dignity for Incarcerated Women Act **NEW** 

Representatives Shevrin Jones D-101 and Amy Mercado D-48 (CO-SPONSORS) Cortes, J.; Eskamani; Grieco; Jenne; Killebrew; Polo

Senator Jason W. B. Pizzo, a newly-elected senator from Miami-Dade, and four other Democrats: Rodriguez, Book, Thurston, and Taddeo

Requires healthcare products, including feminine hygiene products, be made available without prescription to women in any correctional facility of the state or other political division. Restricts male employees in conducting pat-down and strip searches in these facilities, and in entering facilities where women are unclothed.

**SUPPORT** HB 227, S 412 Access to Clinics

House: Amy Mercado D-48 Senate: Linda Stewart (D-013) Amy Mercado is a Democrat from Orlando. Anna Eskamani, co-sponsor, is also from Orlando and is a newly-elected representative. It aims to protect access to reproductive health services clinics by prohibiting injury, intimidation or interference with a client. Also prohibits destruction of the property of such a clinic or its clients. Penalties for violators are specified.

**SUPPORT** H 485, S 430, S 438 Prohibited Discrimination

House: Jennifer Necole Webb, D 69. Margaret Good (Sarasota) is a co-sponsor.

Senate: 430 by <u>Darryl Ervin Rouson (D-019); S 438</u> by Gruters R-23, co-introducers Berman, Pizzo, and Taddeo (D-40)

Relates to prohibited discrimination; adds sexual orientation and gender identity as impermissible grounds for discrimination in public lodging establishments service and public food establishments: provides an exception for constitutionally protected free exercise of religion; revises the purposes of the Florida Civil Rights Act to include sexual orientation and gender identity.

#### **SUPPORT** FL H 579, S 410 **NEW**

Long Acting Reversible Contraception Pilot Program

House: Tracie Davis (D-13) Jacksonville

Senate: Lori Berman D-31 Palm Beach

Requires the Department of Health to establish a long-acting reversible contraception pilot program in Duval, Hillsborough, and Palm Beach Counties.

**OPPOSE** HB 235, Abortion **NEW** no companion Senate bill as yet

Walter Bryan "Mike" Hill R-1 (CO-SPONSORS) Beltran; Sabatini, Hage

Hill is a new representative from Escambia County living in Pensacola. Prohibits termination of pregnancy when fetal heartbeat is detected, which can be at 6 weeks; provides exceptions.

**OPPOSE** S 558, Termination of Pregnancy (no cosponsors or House companion bills as yet)

Joseph Ryan Gruters (R-023)

Prohibition of abortion after 20 weeks because he accepts that the fetus can feel pain. Exception in case of severe health risk to "mother". In this case the abortion has to be done "through or by the method that, using reasonable medical judgment, provides the best opportunity for the unborn child to survive", unless that method would pose a more serious health risk to the mother. Physician has to provide a comprehensive report to the state and the

state will generate an annual report. Another bill, S 560, makes this report confidential. Not only the woman but also the father of the "unborn child" aborted in violation may bring a civil action against the physician. A special revenue account is created to fund the Attorney General's expenses.

**Priority C:** We will study the human trafficking bills and determine which would have most impact HB 219, Victims of Human Trafficking by Tobin Rogers Overdorf R-83

Requires a mandatory minimum term of incarceration for solicitation of prostitution offenses involving victims of **human trafficking**.

HB 259, Human Trafficking. Sponsor Patricia Williams D-92 resides in Lauderdale Lakes

Revises required health education in public schools to include human trafficking; requires DLA to develop & operate hotline to receive reports of potential human trafficking activity & report specified reports to law enforcement for certain purposes.

FL S 540 Human Trafficking. Lauren Book (D-032) Requires the owner or operator of a public lodging establishment to train certain employees and create certain policies relating to <a href="https://www.human.trafficking">human.trafficking</a> by a specified date.

## **Priority D**: Education

A number of bills have been filed regarding Educational Standards for K12 Public Schools, Charter School Funding, and High School Graduation Requirements. We will keep abreast of education bills as there will be more and they will likely be recombined before end of session.

**SUPPORT** SB 114, H 73 High School Graduation Requirements

Senate: Travis Hutson R-7, also Simpson and Benaquisto (both R)

House: Fetterhoff (R26) and Fitzenhagen ((R78); Brannan; Gregory; Grieco; Killebrew; Roach; Sirois Dorothy Hukill submitted a similar bill last year and we supported it because of the financial literacy aspect. This bill is named for her. It has been scheduled in the Senate Education Committee for 2/5/19

Revises the requirements for the Next Generation Sunshine State Standards to include financial literacy; revises the required credits for a standard high school diploma to include one-half credit of instruction in personal financial literacy and money management.

Marjory Stoneman Douglas 1890-1998

Woman Of Interest

"Fashion fades, only style remains the same."

Marjory Stoneman Douglas was an American journalist, author, women's suffrage advocate, and conservationist known for her staunch defense of the Everglades against efforts to drain it and reclaim land for development.

As a young woman, Douglas was outspoken and politically conscious of the women's suffrage and civil rights movements. She was called upon to take a central role in the protection of the Everglades when she was 79 years old. For the remaining 29 years of her life she was "a relentless reporter and fearless crusader" for the natural preservation and restoration of South Florida.
