Section 2. Membership Meetings

The branch shall hold at least 7 meetings during the fiscal year. The branch board of directors shall determine the time and place for these meetings. Any general meeting or meeting of the board, committees, task forces or other sub-groups may be conducted in whole or in part by electronic means as long as. all persons participating whether in person or electronically can hear each other and speak in real time. Woman of Interest



Rosa Parks

Rosa Parks was arrested on December 1, 1955, after she refused to give up her seat on a crowded bus to a white passenger. Contrary to some reports, Parks wasn't physically tired and was able to leave her seat. She refused on principle to surrender her seat because of her race, which was required by the law in Montgomery at the time.

Parks was briefly jailed and paid a fine. But she was also a long-time member of the NAACP and highly respected in her community.

The NAACP realized that Parks was the right person to work on its battle against the system of segregation in Montgomery. It also worked with another group of local leaders to stage a one-day boycott of passenger buses, on the day when Parks went to court.


The group expanded to include other people, chose a name (the Montgomery Improvement Association), and planned an extended boycott.

But the MIA also needed a public spokesman with leadership qualities to make their fight into a wide-ranging cause.

Their pick was a little-known pastor who had recently arrived in Montgomery:

Dr. Martin Luther King, Jr.!

Just when we thought we were getting back to WHAM. Omicron. What normal. disappointment—and what an understatement that is!! We were so looking forward to meeting in person, but NO, back to Zoom. We were so looking forward to our Fashion Show, but NO. So, we are now in the position of having to rely, yet again, on the generosity of you, our members, to make it possible for us to offer our scholarships this year. Everyone was so generous last year that it is hard to come back to you and say, "We really need your help...again." Nonetheless we have no choice because we remain committed to our primary focus "empowering women and girls" through our scholarships.

We are still planning to have our luncheon honoring our scholarship recipients in April. I was motivated to Chair the Scholarship Committee because I was so moved by their stories and the gratitude they feel. They are particularly grateful not only for the material support, but for our demonstrated confidence in their future success. Because of the difference we make in young women's lives, we are asking you, on their behalf, to please help us continue to support the growth and development of future women leaders. We are hopeful that, with your generosity, we will be able to award all our scholarships this year. If you can help, directions for doing so appear on the donation sheet on the final page of the TORCH.

AAUW Star Bright Scholarship: This scholarship was established in 2005, by Book Club 3, to provide branch members with the opportunity to make donations honoring friends and commemorating special events. As funds accrue, a \$1,000 scholarship is awarded to a female student attending the second semester at Fort Myers or Cape Coral Technical College.

AAUW Lee County High School Scholarship: Established in 2011 in memory of Jane Wagner, a three-term branch president. It awards one \$1,000 scholarship per year to a graduating female student with financial need and few other scholarships chosen by the school counselor. The award is paid to the college of the recipient's choice.

AAUW STEM Award: Established in 2001 to encourage middle and high school girls in STEM fields. It awards one \$500 prize to a top female entrant in the Thomas Alva Edison & Kiwanis Regional Science and Engineering Fair. A "First Time" award of \$100 is also given to a female entrant for an outstanding first entry. All Lee County female high school entrants in the Edison Regional Science Fair are eligible.

Marie Glasgow and AAUW STEM Award Fund: Established in 2019 in honor of Marie Glasgow, president of AAUW Fort Myers/Lee Co Branch for two years. It is awarded each year with the goal of improving educational opportunities by rewarding young Middle School girl(s) who are winners at the

Junior Division of Edison-Kiwanis Science Fair or Thomas Edison Festival of Light Regional AAUW Sue Gottcent Memorial Endowed Scholarship: Inventors Fair.

Girls in Engineering, Math and Science (GEMS): This hands-on program is dedicated to science education for regional middle school girls by enthusiastic professionals and undergraduates as facilitators and role models in a girls-only environment.

AAUW FGCU Endowed Scholarship: Established in 2000, with member and matching funds from the AAUW FSW State College Endowed Scholarship: state, it awards one scholarship to a female student who resides in the five-county (Lee, Collier, Charlotte, Glades, Hendry) area with financial need pursuing an undergraduate degree at FGCU. Priority is given to the current awardee.

Established in 2006 with a bequest from the estate of member Sue Gottcent who was an avid supporter of AAUW's mission. It awards one \$2,000 scholarship to a Lee County female student age 25 or older with demonstrated financial need who attends an institute of higher education that is part of the Florida State University system. Priority us given to the current awardee.

Established in 2000, with member and matching funds from the state, it awards one \$1,000 scholarship to a female Lee County student with financial need attending the Fort Myers Campus of FSW. Priority is given to the current awardee.
