# Kristen Ziman, Nationally Known Expert on School Shootings



The speaker for our February 17 program will be Kristen Ziman, a nationally known expert on mass school shootings. Ziman, Chief Executive Officer of Kristen Ziman Consulting in Naples, Florida, where she now lives, is the retired Chief of Police of Aurora, Illinois. Most recently she was called by the U.S. Department of Justice to investigate one of the worst campus attacks in U.S. history, the mass school shooting at Uvalde, TX.

"The end in mind is to investigate the entire incident and determine if lessons can be learned to apply to bettering law enforcement response in future events," she said. It pains me to say that there will be future events, but we've come to the realization that we live in a world where it's not a matter of if, but when, the next mass shooting will occur."

Chief Ziman's extensive police background and years on the force have made her a perfect candidate to author a book on policing. Entitled **Reimagining Blue: Thoughts on Life, Leadership and A New Way Forward in Policing**, it is a passionate and personal look into a misunderstood profession from the vantage point of the first female to *break the brass ceiling* and become the first chief of police in her own hometown.

Since Chief Ziman is waiving her considerable speaker's fee, she hopes that our members will order copies of her new book, which she be referring to in her presentation. ## Woman of Interest 1972: The First Two Female Special Agents in the FBI Were A Marine and a Nun

FBI Director J. Edgar Hoover had a firm rule: only men could be special agents in the FBI . But that rule changed shortly after his death in May 1972, paving the way for the first female modern Special Agents. The two women, Joanne Pierce Misko and Susan Roley Malone, joined their 43 male counterparts at the FBI's Special Agent training course in Quantico, VA, in July 1972.

Joanne Pierce Misko had been a nun in New York for 10 years before getting her start as a researcher with the FBI in 1970. Susan Roley Malone had already broken stereotypes as a U.S. Marine when the FBI began accepting special agent applications from women. They worked hard and wanted to be just like any other agent. "We wanted to be agents first. We just happened to be women."






"Manatee Park is a seasonal location for viewing non-captive Florida manatees in Lee County. Manatees visit the park in search of warm water during the cooler days in winter when the temperature in the Gulf of Mexico is below 68° F. The warm water in the Manatee Park canal comes from the Florida Power and Light power plant and is created as a byproduct of cooling off their equipment.

Mid-December – March: Manatees are more likely to be seen at Manatee Park when the temperature in the Gulf of Mexico drops below  $68^{\circ}$  F

April-November: Manatees are most likely to be seen in coastal habitats in the Gulf of Mexico."

## **CELEBRATING ANOTHER GEMS**

GEMS (Girls in Engineering, Math, and Science) is one of our STEM scholarships and is a hands-on science education program for regional middle school girls. It is held at the Whitaker Center on the FGCU campus. One of its unique features is that, while it is led by professionals, undergraduates serve as facilitators and rolemodels in a girls-only environment.

The second GEMS program of the academic year was held on Saturday, December 2, 2023. The students were split into two groups and had a chance to explore two areas of study.



One group explored spectroscopy, which is the process of documenting and studying light interactions. First students used a dispersion prism and a penlight to consider how light is reflected. Next the students went outside and collected leaves. Inside, they used microscopes to enhance the characteristics of the leaves to find the differences in dry and healthy leaves using light interactions.

Meanwhile, the second group of students participated in a civil engineering activity. First, they learned how important concrete is in our lives today. Next, the students were presented with a variety of materials and given the challenge of making concrete. Small groups competed to see which one could concoct a mixture that would turn into concrete. The students chose materials, measured, weighed, and mixed until they had the perfect combination. The concoctions were poured into plastic cups to dry. The students were very involved in this activity, learning a scientific concept in a fun way.



Later the groups switched rooms and did the other projects. What a great day for this group of middle school students!

Our Lee County AAUW President, Cecile Brennan, also attended the program and said:



"As a former high school teacher. I was heartened to see manv voung SO people gathered on a Saturday morning to listen to college faculty. They did more than just listen. Looking

through a prism led to looking through a spectroscope and analyzing the way light diffused. Throughout the lecture and the experimentation students took notes, collaborated with one another, and offered their reflections back to the undergraduate assistants and faculty members. Seeing these young people in action reaffirmed my view that the future is indeed bright. Heartfelt thanks need to go to the enthusiastic instructors and organizers of this event."



### AAUW Star Bright Scholarship

The AAUW Star Bright Memorial Scholarship was established in 2005 by Book Club 3. It provides branch members with the opportunity to make donations honoring friends and commemorating special events. As funds accrue, a \$1,000 scholarship is awarded to a female student attending the second semester at Fort Myers or Cape Coral Technical College.

**AAUW Lee County High School Scholarship** Established in 2011 in memory of Jane Wagner, a three-term branch president. It awards one \$1,000 scholarship per year to a graduating female student with financial need chosen by the school counselor. The award is paid to the college of the recipient's choice.

**AAUW STEM Awards** Established in 2001 to encourage middle and high school girls in STEM fields. It awards two \$300 prizes based on those projects submitted to the Thomas Alva Edison & Kiwanis Regional Science and Engineering Fair: The AAUW Thomas Edison and Kiwanis Regional Science & Engineering Fair Award goes to a top female entrant; The AAUW Thomas Edison and Kiwanis Regional Science & Engineering Fair Emerging Research Scholar Award goes to a female entrant whose skills are laudable, but still developing.

*Marie Glasgow and AAUW STEM Award Fund* Established in 2019 in honor of Marie Glasgow, president of AAUW Fort Myers/Lee Co. Branch for two years. It is awarded each year with the goal of improving educational opportunities by rewarding young middle school girl(s) who are winners at the Junior Division of Edison Kiwanis Science Fair or Thomas Edison Festival of Light Regional Inventors Fair. *Girls in Engineering, Math and Science (GEMS)* This hands-on program is dedicated to science education for regional middle school girls by enthusiastic professionals and undergraduates as facilitators and role models in a girls-only environment.

**AAUW FGCU Endowed Scholarship** Established in 2000, with member and matching funds from the state, it awards one scholarship to a female student who resides in the five-county (Lee, Collier, Charlotte, Glades, Hendry) area with financial need pursuing an undergraduate degree at FGCU. Priority is given to the current awardee.

**AAUW Sue Gottcent Memorial Endowed Scholarship** Established in 2006 with a bequest from the estate of member Sue Gottcent who was an avid supporter of AAUW's mission. It awards one \$2,000 scholarship to a Lee County female student aged 25 or older with demonstrated financial need who attends an institute of higher education that is part of the Florida State University system. Priority is given to the current awardee.

**AAUW FSW State College Endowed Scholarship** Established in 2000, with member and matching funds from the state, it awards one \$1,000 scholarship to a female Lee County student with financial need attending the Fort Myers Campus of FSW. Priority is given to the current awardee.


# Mail-In Ballots DID YOU KNOW?

All mail-in ballot requests <u>expired at the end of 2022</u>. This has nothing to do with your voter registration. If you were registered to vote in FL/Lee County prior to 12/31/22, you are still registered to vote. However, <u>you must reapply for mail-in ballots</u>.

This is easy to do at **https://www.lee.vote** (If you do not live in Lee County, go to the appropriate website.) Scroll down the home page to find the link to accomplish this. If your address has changed, you must correct that with the election's office. Mail-in ballots cannot be forwarded.

The new requests will expire at the end of 2024.

The next Great Decisions special interest group will meet Friday, March 1, at 12:30 p.m. via Zoom. The topic of discussion will be *Climate Technology and Competition*. As summarized in the FPA website: Will the United States and China, with other powerful countries following suit, approach current and future climate initiatives with an increased commitment to trade protectionism and nationalism, by various measures including trade restrictions? Or could a growing spirit of international accord develop to confront the "common enemy" of climate change?

Great Decisions meets virtually the first Friday of every month (with a couple alterations due to holidays) from 12:30 p.m. to 1:30 p.m. There are eight topics each year. Our branch meets February through June and September through November. Participants purchase a booklet published by the Foreign Policy Association (FPA) to prepare for the discussions and watch a "Master Class" video on the topic. FPA suggests additional readings for each topic, but that reading is at the discretion of the individual participant. Group members take turns facilitating the discussions.

# **PUBLIC POLICY**

### AAUW FORT MYERS/LEE COUNTY Submitted by Suzan Harden skh062653@gmail.com

The 2024 session of Florida's General Assembly began January 9 and runs for 60 days. During that time hundreds of bills will be debated, with some of them becoming Florida law. Advocacy is a major part of AAUW's mission. The AAUW FL Public Policy Committee and board members review the bills that have been proposed and identifies those closely related to the AAUW mission. The following chart summarizes bills AAUW FL has identified for action during this session. Both the House and the Senate must file a version of each bill for discussion to take place. Most bills now are just in the committee phase of the process. This may or may not be a complete list. The AAUW FL PPC and board members will continue to monitor bills throughout the session.
